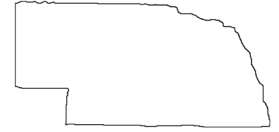




Reporting Spills in Nebraska

* Nebraska law does not allow for spills in any amount. Any party responsible for a spill is expected to immediately, and completely, remediate the area of any contaminants and process the wastes generated in accordance with all applicable rules and policies. Please contact NDEE if there is a spill that cannot be immediately and completely cleaned up. NDEE will assess and advise on potential remedies.
